SPECIAL PROVISIONS AND/OR INSTRUCTIONS

EMPLOYER agrees to provide the following (checked) items:

- ✓ Power
- 4 separate breakers with a minimum of 25 amps per breaker within 25 ft. of stage

- ✓ Sound Board

ARTISTS' sound board must be positioned 25 to 75 feet in front of stage and occupy a space of 4 feet by 4 feet

- ✓ Dressing Room

Room large enough for 9 personnel to change and store personal items. Dressing room to be in close proximity to stage.

- ✓ Food

Employer agrees to provide a deli sandwich tray and soft drinks for 9 personnel

- ✓ Set-up/Break-down Time

Crew will have a minimum of 2 hours before and 1 hour after performance to adequately set-up, conduct sound check and break-down

EMPLOYER, in signing this contract, or in causing the same to be signed by a representative, acknowledges his/her authority to do so, warrants that he/she is at least twenty-one years of age and hereby personally liable for the agreed upon wage stated herein, plus any fees and costs incurred in collecting the agreed upon wage.

Disclaimer

ARTIST's obligations are subject to detention or prevention by sickness, inability to perform, accident, means of transportation, Acts of God, riots, strikes, labor difficulties, epidemics, or any act of public authority, beyond Artist's control. In such case, **ARTIST** shall not be held liable for any claim of damages.

EMPLOYER shall be liable for any and all damages to **ARTIST's** instruments or equipment caused by **EMPLOYER**, his/her guests, business invitees or employees.

EMPLOYER and **ARTIST** agree that this contract is not subject to cancellation unless both Employer and Artist have agreed to such a cancellation in writing.

EMPLOYER agrees that no portion of the **ARTIST's** performance shall be recorded, reproduced, or transmitted from the engagement, in any manner or by any means whatsoever, in the absence of a specific written agreement with **ARTIST** relating to and permitting such recording, reproduction or transmission.

In case of event cancellation for reason out of **ARTIST's** control, **ARTIST's** wages are due in full.

In case of inclement weather, if **ARTIST** is prepared to perform, but is prohibited from doing so, 100% of **ARTIST's** wages are due in full.

In case of venue change due to inclement weather, **ARTIST** must be given a minimum of 3 hours to reset equipment.

If any musicians are unavailable for the engagement, the **ARTIST**, as an agent for the **EMPLOYER**, shall hire such persons as replacements.
